

110 Attended Excellent Guild Conference and Exhibition

With more exhibition stands than we have ever had at an event such as this, which allowed suppliers and cleaners an opportunity to network and share thoughts and ideas. Free entry encouraged many non members to attend on the Sunday although the adverse weather forecast for the weekend unfortunately kept some away who had booked in to attend. With nine separate presentations from speakers, plus a panel hastily put together of dry cleaners each with something different to offer to attract more business and to improve profitability, it was a fast paced day but each session had something different, a message with new ideas and fresh thinking to share with delegates. There was a buzz of interest, a keenness to gain fresh knowledge and the post bag following the conference has been full of praise on the outcome of the day.

On the eve of the Conference Saturday 10th March 2019 Leon Wennekes, Secretary General of CINET and Ken Cupitt FGCL, Chairman of Council of the Guild, signed an agreement "That the Guild should Brand and Market an E-Learning Package created by CINET Exclusively in the UK". It was agreed that the Guild will edit and add where it thought necessary and CINET will market Guild text books within its membership in a reciprocal



agreement.

Alternatives to single use plastics - In previous issues we have mentioned work on finding alternatives to polythene for packaging and we had this has a topic at the Guild Conference in the form of a general discussion, an open forum. It is still early days in the search for suitable alternatives to plastic film in packaging because biodegradable alternatives must be suitable to withstand the warm humid atmosphere within a dry cleaning premises without commencing to early degrade at that point. Also, overprinting of biodegradable alternatives can compromise degradability making them a new problem rather than a solution. Alternatives such as the reusable garment cover may be a short term measure, and these could be made of woven polyester or compressed fibre/felt, or polypropylene, and the customer brings them back for future use. Some cleaners operating this system also clean these for the customer and we have information on cleaning felt in this month's Technical Bulletin. Briefly discussed was going back to packaging in paper but this is more expensive and is not waterproof. Can you help by advising us on what alternatives to plastic film you have come across, or already use. Send any information via email to enquiries@gcl.org.uk News On The Research Project - Professor John Dean and Dr Stephen Reed of Northumbria University, with the help of some senior Guild members and a number of cleaners in the North East of England, work started on this project in January to investigate the cross-bio contamination of textiles in both wet and dry cleaning in low temperature processes. Your Guild, in cooperation with the Worshipful Company of Launderers', and the Northumbria University, are co funding the research project. We will keep you updated on progress.
